No STEM Conference this year

March 13, 2020 -- As I write this, we were all looking forward to the annual STEM Conference on March 30 at the Yuba College campus. This year we would have had a record number of eighth grade girls attending. However, life (and a concern about the Corona Virus) intervened, forcing us to cancel the STEM Conference this year. The two biggest school districts in our counties cancelled all field trips and the ability of the college to host us was uncertain at the time of this writing. It is a shame that this year's group of eighth grade girls will not be able to have the rewarding experience of listening to women in STEM-related fields and see a college campus up close. "With regret, AAUW Marysville-Yuba City is canceling the March 30, 2020 STEM Career Aware Conference for 8th graders at Yuba College.

Based on the Covid-19/Coronavirus March 12, 2020 guidelines the districts with over half of the registered, Marysville JUSD and Yuba City USD Districts, have confirmed the STEM Conference is considered a large gathering and a school field trip so their students would not be able to attend. Registration fees will be refunded.

We will not reschedule this year's conference due to the logistical difficulties, but will look forward to holding the annual STEM Conference (which has been offered to local 8th grade girls since 1985) during the 20-21 school



ADVOCACY & ACTION -- Reproductive

Health for All in 2020 by Claire Noonan, AAUW Public Policy committee, 3/6/20

As American women consider action to ensure reproductive health rights in 2020, it is useful to recall that in the 17th and 18th centuries pregnancy termination was legal under common law before 'quickening' (fetal movement) that occurs approximately 16 weeks after conception.

After 1850 the crusade in the U.S. against voluntary pregnancy termination stepped up. According to Lauren McIver Thompson (author of "Battle for Birth Control ...") physicians, known for irregular practice and lack of training, in order to "establish their place as respected members of society" argued about the 'rights of the unborn' – sound familiar? *New York Times*, December 15, 2019.

By 1900 in accord with the Comstock Act of 1873 most states had passed laws restricting termination and contraception. As a consequence, by the 1930s one report estimated that 681 thousand abortions led to 8 to 10 thousand maternal deaths.

It took a decision by the Supreme Court in 1973 to change the numbers, but the struggle continues. On Friday, January 24, 2020, at the March for Life rally, the president threatened to take away California's federal funding in accord with the Weldon Amendment because of California law that ensures private insurers provide abortion and contraception coverage. The HHS department gave the state 30 days to lift the regulation, saying that the state is not compliant with the amendment. Note that four years ago federal opinion confirmed California's compliance to not discriminate against a health care facility. Yet, Kevin McCarthy (R-Bakersfield) on February 21, 2020, emailed support for health care entities that don't want to supply equal legal health services to all.

After the February 4 president's State of the Union speech there is no doubt women must continue to advocate for reproductive health rights – especially for black and Native American women who have far higher pregnancy-related mortality rates than white women. Of 15 policies suggested by the National Partnership for Women the most important: access to all forms of abortion care and contraception regardless of where you live.

Last, keep track of the U.S. Senate vote on two bills at the end of February: 1) to institute a 20-week abortion ban and 2) to require medical care be delivered to infants that survive abortions, a misleading bill given that infanticide is already a crime.

Secretary's Report - March 12, 2020, 1 pm

The AAUW Executive Council met on March 12, 2020, at 1 pm at Sutter County Schools Annex. Those in attendance were: Liz Skelly, Executive Council Leader, Sandy Davini, Treasurer; Barbara Solheim, Program Group Leader; Janet Theiss, Communications; Joan Young, Projects; and Jeanine Rounds, Secretary. Members at Large present were: Martha Bunce, Nancy Johnston, Joann Nixon

Call to Order, 1:03. **Minutes** of Meeting of February 13 were approved as read.

Projects: Joan Young (Agenda revised to address **Projects** report first.)

STEM: Sandy Davini reported at length about the morning meeting of the STEM committee, dealing both with tasks that need to be done (such as preparing packets, etc) as well as how to handle the issue if the schools determine that, because of the Coronavirus, we need to cancel the March 30 STEM conference. There are approximately 900 eighth grade ladies planning to attend the conference. There are also many women who have volunteered to be facilitators, college staff involved, and much else to be dealt with in the event we have to cancel the conference. (3/13: STEM has just been cancelled.)

Garden Tour: Martha Bunce reported all seems to be going well with the May 2 event. We have 8 locations of various gardens and/or related activities,

Tech Trek: Motion was approved to pay for Tech Trek students and 1 parent per girl for September Branch meeting. Joan Young read a memo from Carol Clark reporting that the student essays had been read by March 1, and 12 young ladies were selected for interviews on March 21. There are now four women doing the student interviews, and Carol is hoping we can have at least one more. Barbara Solheim and Donna Long will do the parent interviews. One of the students will be out of town, but her father is arranging for an active video to allow her to be interviewed! The Pizza Party is scheduled for May 7 at Round Table Pizza, and young ladies who had previously attended the Davis program will be invited. Because Carol is working during the months when most of the TT activity occurs, she is strongly requesting that we help locate a co-chair to work with her.

TEM: Joann Nixon spoke about the role of the previous TT young ladies. There was considerable discussion about how often AAUW should pay for the lunches when TEM students attend our activities. Joann has a budget of \$500, but argued that if we invite the TEM students to a meeting, we should host them. This would include attendance at the September meeting. Related discussion occurred to AAUW paying for the lunches for parents at the September meeting. It was moved that when we invite students to attend branch meetings, we should pay for their lunches, and that for the September meeting, we would cover the cost of one parent for each girl. Motion approved.

Scholarships: Liz Skelly indicated that we will be giving two \$500 scholarships this year, and the date for submission is March 20. Selections must be made by mid-April. Those involved with the selections are Liz, Jeanine Rounds, Barbara

winners for the June and September Branch meetings (as we request them to attend those meetings).

Information/Action Items: Yuba College

AAUW Club: Liz will follow up and see what other branches who have this affiliation are doing.

Annual AAUW Conference in April: Liz and Nancy Johnston both plan to attend, and each has sent in their \$495 registration money. However, given the uproar in the country over the virus, there was concern expressed that the conference might be cancelled. It is assumed that Liz and Nancy would get their funds back if that is the case; however, in the event that is difficult to do, our branch will support them.

Nominating Committee: The information has been provided at the last branch meeting and in the Feather Vane; voting will take place at April meeting.

Public Policy Report: Martha said that this is Women's History Month, and told the group that, despite the 1920 vote option provided for women, African American women were not fully able to vote until after 1965, and American Indian women also find much difficulty.

Reports from Executive Council

Executive Council Leader Report: Liz Skelly reported that she had spoken at the Sutter County Board of Supervisors to indicate appreciation of their recognition of our branch's honoring Women's History Month and the Centennial passage of Women's Right to Vote. She was able to say a few things about AAUW and our goals, and members were very impressed to learn that we have about 900 young eighth grade ladies planning to attend the STEM conference. She will present at the Yuba County Board later in March. <u>Correspondence:</u> Sandy passed out limited correspondence, including an impressive thank you from CASA for our assistance.

Treasurer's Report and Proposed Budget: Sandy Davini reviewed various budget revisions. Yuba County Office of Education has indicated they will support a full scholarship for our Tech Trek program. We purchased a pc and mike and software but will not buy a projector this year. Our annual Tea Bag donation to AAUW E&T Fund request brought in \$855 to date. Motion to accepted Revised Budget as presented was approved.

Membership: Lee Jones was absent, but membership remains the same.

Bylaws: Gwyn Baker is our new Bylaws member.

Communications: Janet Theiss reported all seems to be going well. Feather Vane information needed by 3/16.

Programs: Barbara Solheim reminded members there will be no March meeting because of STEM. The April meeting will be at Yuba College, and the speaker, Rhonda Cameron, will be talking about technology and avoiding fraud, staying safe in cyber space! Unfortunately, a number of the Executive Committee may not be attending, so we need to encourage members to come and to bring guests. There is no May meeting because of Garden Tour, but the June meeting will be held at the Refuge. We have also tentatively scheduled holding our September meeting there. The Program Committee has met and begun planning for the 20-21 year. Gwyn Baker, Nancy Johnston, Sandy Davini, and Jeanine Rounds met with Barbara. For the October meeting, Jeanine has been in contact with the League of Women Voters and they have agreed to provide someone for our branch meeting.

<u>Other Business</u>: Interbranch-Things are quiet. No reports on Historian, Sunshine, Coalition Drawing, or other. Meeting adjourned at 3:00. Respectfully submitted, Jeanine Rounds, Secretary
