Public Policy Brochure

To achieve economic security for all women, AAUW CA advocates:

- Pay equity, fairness in compensation and benefits, and economic justice.
- Equitable access and advancement in employment, through vigorous enforcement of employment anti-discrimination statutes, including age discrimination.
- Strengthening retirement benefits and programs, including public pension viability, and protecting Social Security from privatization or reduction in benefits.
- Programs that provide all women with education, including financial literacy, training, and support for success in the work force.
- Strengthening programs that encourage career development and earning potential, including career and technical education, access to post-secondary education, job training for welfare recipients and training for incarcerated women.
- Policies that support work-life balance, including medical leave, family leave, quality and affordable child and dependent care.

To support a strong system of high quality public education, AAUW CA advocates:

- Vigorous enforcement of federal Title IX (Education Amendments of 1972) and all other federal and California civil rights laws pertaining to education.
- Adequate and equitable funding for high quality public education for all students, including preschoolers.

- Increased support for programs that break through barriers for women and girls in science, technology, engineering, and math (STEM) fields.
- Protection of programs that meet the needs of girls and women in all levels of education and fields of study, including sexual health education and athletics.
- Opposition to the use of public funds for nonpublic elementary and secondary education, and for charter schools that do not adhere to the same civil rights and accountability standards as required of other public schools.
- Support for and adequate funding that gives women and other disadvantaged populations access to higher education, including two-year degree programs and vocational training.

To guarantee equality, individual rights and social justice for a diverse and inclusive society, AAUW CA advocates:

- Self- determination of one's reproductive health decisions.
- Increased access to quality, affordable health care, and comprehensive family planning services.

Book Explorers normally meets at 10 am the third Friday of the month. Contact is Paulette Almeida, 415-5588.



ADVOCACY & ACTION

On August 14, 2020, all schools and colleges will have to implement harmful rules designed to weaken Title IX, reversing important protections for student survivors of sexual harassment and assault. Locally, all k-12 and Yuba College students are affected. It will be harder for victims to come forward and get the help they need, because:

- * Sexual harassment is redefined in an inappropriate way that is narrower and more stringent.
- * Schools can subject victims to drawn-out investigations; coerce victims into participating in mediation with their assailant; and allow victims to be cross-examined in live proceedings. All these are not actions consistent with civil laws such as Title IX.
- * Schools can ignore victim complaints if the harassment occurred at the wrong place outside of a campus-controlled building or activity such as an away game or was reported to anyone, such as a teacher, or coach instead of one of the two designated persons to be named by the schools.

Title IX, the landmark civil rights law, was enacted on June 23, 1972, prohibiting sex discrimination in any education program or activity that receives federal funds.

The new rules reverse policies that were put in place to make it more likely that survivors report sexual

misconduct. They stack the deck against survivors (students already at risk), making it too onerous for many to come forward. In short, the rules are antithetical to the fundamental promise of Title IX: that all students deserve access to an education free from sex discrimination.

Please join AAUW Marysville-Yuba City in demanding the new rules be rescinded. Contact your Representative and Senator. Protect our children.

Call to Order, 10:05 a.m. Nancy Johnston was appointed to take minutes.

Information/Action Items:

May14 minutes were approved by all, with the addition of Nancy Johnston as Co-Chair on the Tech Trek Committee.

Kathy Nehl and Linda Zall were appointed Members at Large. Artis Buerki made the motion, Sandy Divini seconded, motion passed.

The next EC meeting will be on Friday, **August 14th**, 1pm. We need to determine if our Program meeting for September at The Refuge is still on, and if not, let The Refuge know.

Reports from Executive Council

EC Leader's Report: Liz Skelly - Position changes within the Executive Council EFFECTIVE JULY 1, 2020 - Barbara Solheim will no longer be the lead for Programs or Co-Chair of the STEM committee. She'll return to being a regular branch member. Joan Young will no longer be the Project Lead, she'll be a Member at Large of the Executive Council. Gwyn Baker was previously appointed to the Executive Council as Lead for By Laws last spring. Today she was

appointed the new Lead for Programs, taking Barbara Solheim's vacated position. Artis Buerki was appointed the Lead for By Laws. Martha Bunce was appointed Project Lead, taking the position vacated by Joan Young. Jeanine Rounds has completed her term and will become a Member at Large of the EC. She and has turned the Secretary's job over to Nancy Johnston. Sandy Davini made a motion that Martha and Artis be appointed to the Executive Council, and Joann Nixon seconded; motion passed.

After discussion of EC responsibilities, officers agreed to following assignments for 20-21: EC Leader-Liz Skelly; Secretary-Nancy Johnston; Treasurer-Sandra Davini; Bylaws Leader-Artis Buerki; Communications Leader-Janet Theiss; Membership Leader-Lee Jones; Program Leader-Gwyn Baker; Projects Leader-Martha Bunce. Members-at-Large: Barbara Alves, Carol Clark, Gretchen Cupp, Kathy Nehl, Joann Nixon, Joan Young, Linda Zall, Jeanine Rounds.

Correspondences: Nothing to report

Treasurer's Report/Proposed 20-21 Budget: Sandra Davini: Prioritizing the line items in the budget: Top Priority is STEM, TECH TREK, and GARDEN TOUR. Lower Priority is Convention, Donations, and Chamber of Commerce. Martha Bunce made a motion to remove Chamber from our budget, Lee Jones seconded, motion passed. Martha also made a motion to adopt the prioritization, Sandy seconded, motion passed. Martha made a motion to adopt the budget as Sandy presented, minus Chamber, Carol Clark seconded, motion passed. Executive Council unanimously approved adding Elizabeth (Liz) Skelly as a signatory on AAUW Umpqua bank account. Liz will be added to the current signatories, Martha Bunce, Sandra Davini, Barbara Solheim. Nancy Johnston will prepare minutes and a letter to Umpqua Bank.

<u>Public Policy, Advocacy</u>: Martha Bunce will send all members an email saying that she will forward state and national alerts unless they respond negatively to her. Artis will post the same alerts on our website.

Membership: Lee Jones reported we lost 12 members, and gained 19 new members, since some period of time. We gained 4 new members last year. Our total as of Feb 2020 was 86 members. 39 have paid their membership dues as of 6/11/20. Liz will send a letter to all unpaid members encouraging them to pay their dues. The drawing for a year's free membership was held and Jeanine Rounds won.

Bylaws: Gwyn Baker passed all information she had to Artis Buerki, the new Lead.

<u>Communications</u>: Committee Chairs need to contact their members and confirm that they will stay on the committee this coming year. The information needs to be to Janet Theiss by **August 1**st for the Roster. The AAUW

TEAM OF EXTRAORDINARY MINDS: Joann Nixon is notifying the TEM girls and hopes to have them present for the September meeting.

SCHOLARSHIPS: Liz Skelly reported the Yuba College girls that won the scholarship were notified at the end of May. Liz will write something for the Feather Vane and invite the girls to our September meeting. She'd like to invite them to future meetings so we can see how they have progressed over time.


