## **Scholarship Winners**

Our branch scholarships were awarded in May, 2020 to two outstanding Yuba College students. Let me introduce you to BRISA BARRIGA and TESSA CHARTOCK.



**Brisa Barriga** plans a career as a pediatric nurse practitioner. She is a first generation college student who took advantage of college courses while enrolled in high school. She was a member of the California Scholarship Federation all 4 years of high school and received the state seal for her academic achievements in Spanish. She was a National Honor Society Scholar, played violin in the orchestra, and played Soccer in high school. She is currently playing Soccer on the Yuba College Team. She was selected to be a part of the Rideout Teen Leadership Council where she discovered her love for medicine as a career. Here is part of what Brisa wrote about herself:

"I graduated High school with a 4.1 GPA and I currently have a 3.8 GPA while attending Yuba

College. Even though I have developed my character through my involvements, my life has always had this label of limitation permanently stuck on it. I am an undocumented student who has been in a constant struggle to show that my capabilities are more valuable than a paper declaring my residency. As a DACA recipient, I am able to continue my education yet so much of my future still remains an unknown. I can be stripped of my opportunity and be left with only the dreams of making the most out of what my parents provided for me. My parents were never financially stable, however, they taught me consistency. My residency or money was never an excuse that stopped me from preparing myself and taking advantage of the opportunities that presented themselves to me. Yet, so many will still only be able to see me as someone who is undocumented. The word itself is so identifying, that no matter what you say, it's the part that will always stick out. My goal is to strip that label off, to be able to say that, yeah, I am an undocumented student, but I am one who took every possible opportunity available to be where I am today as a pediatric nurse practitioner."



**Tessa Chartock** is a busy full-time mom, and a committed student in the nursing program. Here is what Tessa wrote about herself:

"I started volunteering in the special education preschool program at Champion Mine School from 1997 to 1999. This led to my being hired as a teaching assistant during summer school once I was 15; I continued to go back each summer after. The summer following my senior year I was recommended to a nice couple with an extremely autistic child and I began working as an in-home tutor for their little boy. The fact that I had earned the trust of this student and had a history with the

County led to my being hired as a full-time teaching assistant, (TA) by the Superintendent of Schools, in order to help this child transition smoothly into kindergarten. This job was intense, I had not realized that I would also be working with medically fragile children and would find so much joy in it. The ability to help my students and the enjoyment that it brought me, has been a guiding force in my wanting to pursue Nursing as my career. The only thing stopping me was the fact that I would have to go back to school, so I put it off.

In 2011 I became a mother! What an adventure and, also a real motivator. It was after the birth of my daughter that I decided I was going to go back to school. I knew that with school I could become the best version of myself and that eventually it would help me reach a place where I could better provide for my family. I became a full time stay at home mom and a part time student. I started with the classes that I struggled with the most in high school (English and Math). At the end of my first semester (and after many tears) I decided to get tested for learning disabilities, of which I have a few. The DSPS staff helped me overcome and embrace my learning disabilities by providing the right tools and accommodations to help me succeed. Halfway through my math requirements, I became pregnant with my second daughter, I was able to complete Math D three weeks before my due date (that was nerve wracking). I took a year off to be with my family, then it was back to the grindstone. I have now completed all my prerequisites for the Yuba College Nursing program and have been accepted in to the ADN program."

"Throughout all my struggles I have watched, taught and helped my children grow and have been working hard at being the best role model that I can be. This way the young women I am raising, who are presently 6 and 8 years old, will someday grow up to be successful, compassionate, free thinking members of our society."

Did you know that women in California had the right to vote 9 years before the 19<sup>th</sup> Amendment was passed? By Artis Buerki, Editor

On **October 10, 1911** the citizens of The Great State of California voted to give women of CA the right to vote. California was just the 6<sup>th</sup> state to pass this law. Louise Wall, Elizabeth Watson, John Hyde Braly, and Clara Foltz are four of the people in CA who worked so hard to make this happen. This poster was used in that campaign. Do you see the Golden Gate in the background?

The 19<sup>th</sup> Amendment to the U.S. Constitution was ratified nine years later, on **August 26**, **1920**, making it possible for women in America to vote. But the 19<sup>th</sup> Amendment, widely thought of as giving women the right to vote, did not fully deliver on its promise. Native Americans and Asian American women were not granted voting rights. And, due to Jim Crow laws and other voter-suppression tactics, Black women and Latinas couldn't cast their ballots until the Voting Rights Act was passed 45 years later prohibiting racial discrimination in voting. It was signed into law by U.S President Lyndon B. Johnson during the height of the civil rights movement on **August 6**, **1965**, and Congress later amended the Act five times to expand its protections.

This year we celebrated the Centennial of the 19th Amendment to the United States Constitution on August 26, 2020. That date is called EQUALITY DAY. Read more on this website:



#### **ADVOCACY & ACTION**

On August 14, 2020, all schools and colleges will have to implement harmful rules designed to weaken Title IX, reversing important protections for student survivors of sexual harassment and assault. Locally, all k-12 and Yuba College students are affected. It will be harder for victims to come forward and get the help they need, because:

\* Sexual harassment is redefined in an inappropriate way that is narrower and more stringent.

\* Schools can subject victims to drawn-out investigations; coerce victims into participating in mediation with their assailant; and allow victims to be cross-examined in live proceedings. All these are not actions consistent with civil laws such as Title IX. \* Schools can ignore victim complaints if the harassment occurred at the wrong place — outside of a campus-controlled building or activity such as an away game — or was reported to anyone, such as a teacher, or coach instead of one of the two designated persons to be named by the schools.


# Title IX, the landmark civil rights law, was enacted on June 23, 1972, prohibiting sex discrimination in any education program or activity that receives federal funds.

The new rules reverse policies that were put in place to make it more likely that survivors report sexual misconduct. They stack the deck against survivors (students already at risk), making it too onerous for many to come forward. In short, the rules are antithetical to the fundamental promise of Title IX: that all students deserve access to an education free from sex discrimination.

Please join AAUW Marysville-Yuba City in demanding the new rules be rescinded. Contact your Representative and Senator. Protect our children.

#### AAUW CA Strengthens Commitment to Increasing Equity for Black Women and Girls

In 2020, a widespread protest movement has emerged, clearly and loudly demanding greater racial equity through systemic change. This protest movement is in line with the core mission of AAUW: "To advance gender equity for women and girls through research, education, and advocacy." How are these two aligned? AAUW's central mission statement implies a focus on ALL women and girls. To achieve this mission, we must demand greater equity for black women and girls.

At the national level, AAUW has acknowledged that the organization has historically fallen short of this goal, as it has lacked diversity and inclusion in leadership, membership, and focus. AAUW has taken concrete steps to create organizational change, to better address their mission of serving all women.

Individual AAUW members can also take concrete steps to make sure that the inclusive mission of AAUW is made into a reality—here with a specific focus on racial equity for black women and girls. One way this can be done is through white members learning about and engaging in antiracism and white ally-ship.

Anti-racism is the active practice of calling out racism when it is encountered, which may include having uncomfortable conversations about race and racism in everyday life. Nonracism, the internal and often silent opposition to racism, is positive, but it is not enough to create necessary change. Related to anti-racism is white ally-ship. White allies are people who make the long-term commitments and efforts necessary to recognize their racially based privilege and who continually work in solidarity with oppressed groups engaged in institutional and political struggles for justice.

We hope you will join AAUW CA's webinar on August 26<sup>th</sup> to learn what concrete steps you can take to ensure that the inclusive mission of AAUW will someday become a reality. *Editor's Note: After that date you may be able to view the webinar on aauw-ca.com.*
